Issues and Solutions

<u>Challenge</u>

- MMS has conflicts with music rehearsal and remedial on Tuesdays and fewer music rehearsals
- MMS students have to choose between clubs and athletics during period 10

<u>Solution</u>

- Create a period 10 schedule that mirrors zero period at POBMS
- Utilize period 10 at MMS to hold additional music rehearsals and eliminate the conflicts with remedial
- MMS delay the start of all sports until 3:45 p.m. to allow athletes the opportunity to participate in clubs

Cost/Concern

- Delaying the start of some music
 rehearsals 45
 minutes after school
 may reduce
 participation
- All athletics will start 90 minutes after school day at MMS
- Utilize an aide for supervision

Athletic & Music Program

- Beginning with the Winter I season (2013-14) all Athletics began at 3:50 p.m. in both schools to alleviate conflicts and to have more students participating in clubs at MMS
- An additional aide was needed for supervision
- Utilized period 10 at MMS to hold additional Music rehearsals (2014-15)
 - Eliminated the conflicts with remedial and Music

Eleven Proposals Considered

Proposal #1 Summary:

- As previously articulated in this power point as presented by the administration team to the Board of Education on September 30, 2013
- Mattlin MS would implement a 10th period that mirrored the Zero period at POBMS

Discussions:

- Implemented 2014-15 school year with a 3rd remedial day available to students as of November
- No additional cost for transportation; however, MMS athletes had a long day with this schedule as they had to wait around for the program to begin at 3:50 pm after having started their day at 8:00 am. POBMS starts their day at 8:43 am (Zero period starts at 7:52 am)
- The later day presented a conflict for students participating in religious obligations (Hebrew School and Confirmation) . Central Office met with local clergy to problem solve.
- An additional aide for approximately two hours per day came at a cost of \$10,925.
- <u>Transportation</u>: \$0 <u>Staffing:</u> \$10,925 <u>Total:</u> \$10,925



Proposal #2 Summary

• Both Middle Schools on the same schedule and the Kindergarten Center on Mattlin time.

Considerations and Concerns:

Committee agreed Kindergarten on Mattlin time was too early thus no cost was configured.

Proposal #3 Summary

• Two of the elementary schools will be on an early schedule and two will be on a late schedule thus allowing for Mattlin's day to become the same as POBMS.

Considerations and Concerns:

- Creates differences between elementary schools
- > Elementary articulation and shared staff issues
- > To accommodate this change, we would need seven additional vehicles.
- Project Challenge Program affected
- Total Cost: \$560,000

Proposal #4 Summary

- Start Mattlin earlier with zero period.
- Keep all Elementary Schools on the same schedule.

Considerations and Concerns:

All agreed too early for Mattlin students to be at a bus stop thus no cost was configured.

Proposal #5 Summary

- Make Mattlin Middle School a 5/6 school and POBMS a 7/8 school.
- All other schools remain status quo.

Considerations and Concerns:

All agreed this would be too many transitions with other unforeseen issues thus no cost configured.

Proposal #6 Summary

Consider closing the K-Center to bring the two middle schools at the same time, with the same programs

- Cost savings anticipated through administrative restructuring
- POBMS and Mattlin on the same schedule and K-4 schools on the same schedule

Considerations & Issues:

- The school times have been modified to achieve this change to minimize the cost to the district. The High School bell schedule is not affected.
- Is there room in Elementary schools and what would be the cost of reconfiguring?

Proposal #7 Summary

•

- Create a Mattlin 5 & 6 Middle School and a POBMS 7 & 8 Middle School
- K-4 Elementary Buildings
- Reduction of late buses for ninth period at the high school.
 Considerations and Concerns:
- In this option, the distance some students would have to travel to the centralized middle school. (Middle school students on average do not travel more than 30 minutes on a school bus. Some students could see an increase in their travel times by 15 minutes or more due largely to traffic rather than distance.)
- Replacing K transition with a MS transition does not solve the problem
 Zero period start time of 7:35 am considered too early
 Total Cost: \$347,000

Proposals #8 Summary

- Both middle schools are on the same schedule.
- Elementary schools & Kindergarten Center remain
- Change in bell schedule for primary and secondary schools
- Reduction of 9th period buses at the HS
- Utilize more large school buses by converting 5 vans to larger buses.

Considerations and Concerns:

- > High School would start -7:00 am
- MS Starts at 7:25
- Committee not in favor of early secondary starts

Total Cost \$107,000

Proposal #9 Summary

- Both Middle schools are on the same schedule
- Elementary schools & Kindergarten Center remain
- Change in bell schedule for primary and secondary schools
- Reduction of 9th period buses at the HS
- Utilize more large school buses by converting 5 vans to larger buses

Considerations and Concerns:

- HS Starts at 8:28 am with Tenth Period at 4:15 pm
- Impact on Athletics and Clubs
- Kindergarten Center would start too early 7:30 am and Middle Schools at 7:00 am – Committee not in favor of times

Total Cost \$107,000

Proposal #10 Summary

- MS on same schedule with start time at 7:20am
- K Center time shifts to later 9:20 am
- HS remains at the same time

Considerations & Concerns

•Mattlin students would be picked up at 6:55am, this is too early

•Additional supervision needed between 7:10 and 7:20 am

•In order to get to this figure, we would be eliminating six busses – 9th period at the high school

•K Center late start needs to be communicated to parents

•Additional supervision needed between 7:10-7:20am daily

Superintendent's Recommendation

- Consider implementing Proposal #11 for the 2015-16
 School Year
 - 2015-16 budget should reflect the additional cost of \$107,000 to address transportation for this proposal
 - Provide timely notification of schedule to all schools
- Develop a plan for moving K into the elementary schools for the 2016-17 school year
 - Ready classrooms over the summer of 2016
 - Bond referendum has two classrooms to address increased enrollment, if needed (\$300,000 per classroom)
 - Monitor enrollment pattern for Pasadena and Parkway to make recommendations for additional classroom space

Superintendent's Recommendation Contd.

- SRC committee should continue with a secondary focus to explore the implementation of a 9 period day grades 5-12
- Timeline for report to the Board of Education should be February 2016 for consideration in the 2016-17 school year
