


# 2013-2014 Proposed Budget

## A MESSAGE FROM YOUR BOARD OF EDUCATION

Dear Residents,

The Plainview-Old Bethpage Central School District has developed the proposed 2013-14 budget which **preserves** the district's distinguished academic and extra-curricular programs. The proposed budget increase is **2.98**%, with a corresponding tax levy increase of **2.89**%. This is under the amount calculated by the 'tax cap.' One of the ways that this has been achieved is that all staff members have taken a **pay freeze** for the 2013-14 school year. This will enable us to maintain our level of excellence in our academic offerings within the established fiscal parameters.



The proposed 2013-14 budget outlined on these pages maintains class size, as well as the outstanding programs and services that have enabled our students to excel. These include:

- Research programs
- Advanced Placement courses
- Project Challenge enrichment
- Life Skills program

- Special education summer program
- Music and Art program
- Elementary global language program
- Interscholastic athletics
- Co-curricular clubs/activities
- DECA and Robotics
- Partnership with North Shore-LIJ

The proposed budget also provides for the completion of several much-needed capital projects:

- Partial roof replacement at POB Middle School and POBJFK High School
- Installation of an emergency generator

# PROPOSITION II: FUNDING OF A REPAIR RESERVE

In addition to voting on the 2013-2014 School District's budget, Plainview-Old Bethpage CSD residents are also asked to vote on Proposition II — a resolution to fund a repair reserve for the District. A repair reserve can be extremely useful and can be utilized to allow the District to perform unanticipated repairs that do not recur annually. Given the age of our infrastructure, the buildings require unexpected maintenance from time to time. For example, we may incur roof leaks, issues with our pools or the need for masonry repair to our exterior walls. The repair reserve fund would allow us to make these essential repairs and protect our infrastructure to ensure a safe school environment.

The Board of Education established the repair reserve in April 2013, and the next step in the process is for our voters to consider the approval of the funding. The repair reserve would be funded by unanticipated revenues and unexpended funds accumulated at the end of the current year and would not increase the proposed 2013-14 tax levy.

We are recommending that the repair reserve not exceed \$1,000,000, and this reserve would be utilized only upon approval by the Board of Education based on a public hearing requesting the reserve's use.

## **BUDGET Q & A**

### Does the Board of Education set the tax rate?

No, the Nassau County Assessor's Office sets the tax rate. The Board of Education sets only the budget amount and the amount of the corresponding tax levy (the total amount of tax dollars needed to support the budget). The 2013-14 proposed budget is increasing by 2.98 percent, and the tax levy is increasing by 2.89 percent.

# Is the District proposing a tax levy increase greater than the Maximum Allowable Levy amount?

No, the District's tax levy limit under the tax cap legislation is set at 3.08 percent; however, the proposed tax levy increase is 2.89 percent. The proposed tax levy is \$216,659 less than the allowable limit.

# Last year was the first year of the two percent tax cap. Why did my property tax bill increase more than two percent?

The tax cap legislation, which is commonly referred to as the 'Two Percent Tax Cap,' is determined by an eight-step formula provided by the state with various factors for each individual school district. This calculation has been posted on the District's website. There are certain exemptions and exclusions that, in some cases, may increase the allowable tax levy greater than two percent. Furthermore, the tax cap legislation is applied to the school district's tax levy, not individual property taxes.

# THE IMPACT OF THE TAX LEVY CAP ON A CONTINGENT BUDGET

Since the District's proposed tax levy is less than the allowable tax levy limit, a simple majority is required for the 2013-14 budget approval. In the event that the proposed budget was not approved by the voters, the Board of Education has an option of proposing a second budget vote in June, or they may adopt a contingency budget. If the second proposed vote is not approved by the voters, then the District will need to adopt a contingency budget. The rules for contingency budgets have changed. There is no longer a spending cap on contingent budgets. Instead, there is now a zero-percent cap on the tax levy increase for a contingent budget. In other words, a district would have to levy the same amount, or less, in taxes as the current year's tax levy without adjustments for any increases, mandated or not. This would result in the District removing over \$3.3 million from the proposed budget.

## **PROPOSITION I: Annual School District Budget**

Authorization to spend up to \$141,358,095 to support educational programs in the 2013-14 school year.

### PROPOSITION II: Funding of a Repair Reserve

Authorization to fund a repair reserve not to exceed \$1,000,000 to be used for unanticipated maintenance with no increase to the proposed tax levy.

## **BUDGET VOTE INFORMATION**

**Voter Eligibility:** In order to vote, you must be a United States citizen, 18 years of age or older, and must have been a District resident for at least 30 days prior to the vote. Eligible voters include those who have voted in federal, state, county or school District elections within the past four years; those who are registered with the Nassau County Board of Elections; and residents who registered during the school District's registration period.

**Absentee Ballot:** Applications for absentee ballots must be received by the District Clerk one week prior to the vote. If an absentee voter intends to pick up the ballot in person, that application must be filed with the District Clerk by 5 p.m. on the day of the vote. Persons designated by the Nassau County Board of Elections as "permanently disabled" will automatically receive an absentee ballot by mail.
